## Rules & Regulations for P.L.Y.C. Clubhouse and Grounds.

- 1. The clubhouse and grounds are available to all members, and their guests, for their use and enjoyment during the sailing season. It is the responsibility of each and every member (and guest) to care for the club property, abide by the club rules and to report any violation to the officers. No unauthorised parking will be permitted.
- 2. The clubhouse and grounds may be used daily.
- 3. In sanctioning and conducting sailing activities, including racing, neither Pigeon Lake Yacht Club nor any of its agents assumes in any manner any responsibility whatsoever for participating sailing craft, their crews or guests.
- **4.** P.L.Y.C. its Directors and members are not responsible for any personal or private possessions on property under P.L.Y.C. jurisdiction. This includes, but is not limited to: boats, trailers and other equipment.
- 5. Owners are responsible for maintaining public liability insurance on their boats trailers and equipment. Uninsured items must be immediately removed from the P.L.Y.C. grounds, clubhouse and docks.
- 6. Children under the age of 13 are not to be left unattended on P.L.Y.C. grounds.
- The P.L.Y.C. hoist is available to club members or guests accompanied by a member from "docks in" to "docks out". Children under 14 shall not use the hoist without adult supervision.
- 8. Guest's boats may be moored at P.L.Y.C. buoys or docks overnight only with the permission of yacht club officers.
- 9. After 3 times as a guest to P.L.Y.C., the individual must decide if they wish to become a member of the club.
- 10. It is recommended by the Board of Directors of P.L.Y.C. that approved PFD's be worn when on the water.
- 11. All children 8 years and under must wear a government approved PFD while on club docks.
- 12. No fishing at any time is allowed from P.L.Y.C. property.
- 13. No dogs or other animals are allowed on P.L.Y.C. property unless they are under control.
- 14. Water skiing from P.L.Y.C. docks is not allowed.
- 15. Swimming from the docks, while racing activities are in progress, is allowed only by special permission of the Fleet captain or a member of the Race Committee.
- **16.** Racing equipment, such as guns, flags, buoys, etc. cannot be used without the permission of the Fleet Captain or a member of the Race Committee.
- 17. No P.L.Y.C. property may be loaned at any time.
- **18.** At the end of the sailing season all boats must be removed from club property unless arrangements to the contrary are made with club officers, subject to a fee and rule 4.
- Prior approval by the P.L.Y.C. Communications Committee is required before payment for photographs taken by club members is made.
- **20.** Members who need temporary power to charge batteries or do maintenance on their boat may run an extension cord from a GFI outlet, whether at the hoist, keel boat dock or other location. Power cords <u>must</u> be kept out of the water for safety.
- 21. Keel Boats at the P.L.Y.C. keelboat docks are limited to a length of twenty-seven feet (27') overall.. Dockage to other boats can be offered only when appropriate dock space is available, and allocated according to the waiting list.
- 22. Winter boat storage is only available to those who have been allocated a wet slip for the previous season and/or a member of good-standing at the discretion of the Directors.
- 23. A member who is absent from PLYC property for a prolonged period of time must make advance arrangements with the Waterfront Director for the care and control of their boats and equipment.
